I hereby give consent to my child _____ to join the Overseas Education Tour to Seoul, South Korea from 10th to 13th April 2011 organised by St. Stephen's College Preparatory School. I agree to him/her taking part in all the activities proposed.

I have ensured that my child understands that it is important for his/her safety and the safety of the group that he/she obeys all rules and instructions given by the staff-in-charge.

I understand that during the tour St. Stephen's College Preparatory School is going to provide gratuitous assistance to the students as a mere facilitator without liability. Whilst the accompanying staff from the school and helpers in-charge of the group will take all reasonable care for their health and safety, they cannot be held responsible, for any injury, illness, damage or loss suffered by my child during or arising out of the journey.

I understand that the accompanying staff will take all reasonable care of my child, and I authorise the accompanying staff from St. Stephen's College Preparatory School to seek medical advice on behalf of my child as they see fit in the event of accident or illness. If in the opinion of the attending medical practitioner or medical officer, my child requires medical attention or treatment

including but not limited to the administration of anesthetic, blood transfusion or the performance of any surgical operation, I consent to attending medical practitioner or medical officer giving such treatment for my child in the course of the trip.

I, therefore agree to indemnify St. Stephen's College Preparatory School and its employees against all liabilities, which may occur to, or be suffered by my child while he/she is attending the tour in Seoul. This applies from the time of departure from Hong Kong International Airport until his/her returning home and waives all the rights as the parent /guardian or the student may have against St. Stephen's College Preparatory School in respect of the Overseas Education Tour. I also hereby indemnify St. Stephen's College Preparatory School against all claims, damages, demands, losses and proceedings whatsoever in respect of any of the matters aforesaid.
